## RECTOR OF UNIVERSITAS TIDAR,

## Considering

- a. that following the provisions of Article 5 paragraph (l) of the Regulations of President, Number 33 of 2012 concerning the National Legal Documentation and Information Network, agency leaders must form legal documentation and information network organization;
- b. that based on considerations as referred to in letter a, it is necessary to stipulate the Regulation of the Rector of Universitas Tidar regarding Documentation and Information Network of Law at Universitas Tidar (JDIH Untidar);

# CHAPTER I GENERAL REQUIREMENTS

### Article 1

In this Regulation what is meant by:

- Universitas Tidar, hereinafter referred to as Untidar is an institution of higher education that provides Academic Education and can provide vocational education in various fields of science and/or technology and if it meets the requirements, it can provide professional education.
- 2. The Rector is the Leader of the Higher Education Institution within the Untidar environment.
- 3. Educational staff are members of the community who possess specific competencies and are appointed to support the implementation of education.
- 4. The Academic Community is a unit consisting of Lecturers and Untidar Students.

- 5. Universitas Tidar Legal Documentation and Information Network, which is hereinafter abbreviated as JDIH Untidar, is a platform for the collaborative utilization of legal documents within the environment of Universitas Tidar in an orderly, integrated, and continuous manner, serving as a means to provide a means for delivering comprehensive, accurate, easy, and fast legal information services.
- 6. Legal Documents are legal products in the form of statutory regulations or legal products in addition to statutory regulations which include but are not limited to court decisions, jurisprudence, legal monographs, legal magazine articles, law books, legal research, legal studies, academic texts and draft regulations legislation.
- 7. information is all data and information contained in legal documents.
- 8. Legal Documentation and Information Management is the collection, processing, storage, preservation and utilization of legal information.
- 9. JDIH *Corner* is platform electronics in the Universitas Tidar environment which is used for accessing the JDIH Untidar website.

# CHAPTER II VISION AND MISSION

### Article 2

- (1) JDIH Untidar has a vision To become an effective, transparent and accountable Legal Information Center for society.
- (2) JDIH Untidar has a mission:
  - a. develop information and documentation systems based on general principles of good governance;
  - realizing an integrated legal system based on optimization technology information; And
  - c. ensure availability of accurate, credible and transparent legal documents.

# CHAPTER III MANAGEMENT

## Article 3

Management of JDIH Untidar is carried out by the Development and Management Team under the coordination of the Planning, Finance and General Bureau as determined by the Rector's Decree.

JDIH Untidar can be accessed through the website <a href="https://jdih.untidar.ac.id">https://jdih.untidar.ac.id</a>.

## Article 5

Management of JDIH Untidar includes:

- a. Collection, processing, storage, preservation and utilization of information on legal documents published within the University;
- The development of a legal information system based on information and communication technology that can be integrated with the JDIH Untidar website;
- c. The nurturing and development of human resources for the management of JDIH Untidar, the academic community, and educational staff at Untidar in the field of law;
- d. Provision facilities and infrastructure management of JDIH Untidar;
- e. Coordination of the management and development of JDIH Untidar with the supervising agencies of JDIH, both at the provincial and central levels and/or with fellow members of JDIH; And
- f. Evaluation of the management and implementation of JDIH Untidar is carried out at least once a year.

### Article 6

To facilitate the management of JDIH Untidar, the Documentation and Legal Information Network Development and Management Team of Universitas Tidar (JDIH Untidar) is established and appointed by the Rector.

## CHAPTER IV FACILITIES AND INFRASTRUCTURE

### Article 7

To facilitate access to JDIH Untidar services for the community, especially the academic community and educational staff, JDIH Corners are placed in strategic locations within the Universitas Tidar campus.

## CHAPTER V FINANCING

### Article 8

The implementation cost of the management of JDIH Untidar is charged on the Universitas Tidar DIPA budget allocation according to the applicable year.

# CHAPTER VI CLOSING

## Article 9

The Rector's Regulation regarding the Documentation and Legal Information Network of Universitas Tidar (JDIH Untidar) shall come into effect on the date of its determination.
